SECTION 4: First aid measures

4.1. Description of first aid measures

Take care of your own safety. If any health problems are manifested or if in doubt, inform a doctor and show him information from this safety data sheet. If in eyes

Rinse eyes immediately with a flow of running water, open the eyelids (also using force if needed); remove contact lenses immediately if worn by the affected person. No neutralization should be performed in any case! Rinsing should be continued for 10-30 minutes from the inner to the outer eye corner to make sure that the other eye is not involved.
